

**Grand Jury Trial Proceedings on February 12, 2024:**

Read by Charlie White, Director of the Action Committee, before an on-line (Skype & Free-Conference Call) gathering of 36 men-women in the Oregon Statewide Jural Assembly jury pool with their bona fides affirmed.

Prayer:

As we recognize that we are of Prime Creator,  
so are we the living mind-body-soul-flesh-blood-Spirit men, women with their progeny on the land, soil and dirt of our State known as Oregon, here "...to assume among the powers of the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle them...."

As stated by an OR State Representative, Mike McLane:

"Freedom of thought and expression are fundamental to a free society. Our duty to protect our liberty begins with knowing the limits that our Constitution places on Oregon's government." And I will add, on ANY governance!!

To be truly free, we are no longer experiencing the original jurisdiction of Common Law and the laws closest to God's law and the laws of Nature, but rather, we are needing to be aware of the perversions set upon us by Washington D.C. -- the Washington Death Cult -- with their minions of followers of statutes, ordinances and codes -- with an excess and a criminality our founding fathers thought well to take into account to the best of their ability, yet knew NOT, how perverse and defiled governance has become.

This gathering of awake and aware beings on this call and attendant are called to action to hear and vote on evidence in this case and cause of Right to Travel and the failure of Due Process for which the defendant will be pressing charges.

You will hear a series of occurrences...to but one woman on Oregon who took personal responsibility to truly learn the laws, the legislations -- literally, the rules of the road -- and her rights as a free woman of our Creator on the land and soil, Oregon. You are here as a Grand Jury and/or as a witness in the de jure form of Common Law -- that of the people on the land and soil; unlike the stolen de facto Grand Juries now performed by corrupt judges in monetized courts, required by costly attorneys who are foreign agents practicing a foreign form of law -- and all to make us indentured "criminals."

In our Oregon Constitution, the use of all roads, ways and waterways are...declared a public use." Because the D.C.ers think everything is about commerce and making money, we are lumped into that by being their chattel from birth to death. No less true when ensnared into the court system.

"All state driver's license and motor vehicle code derives authority from a broad interpretation extended from the "commerce clause" in the U.S.Constitution. Most states -- especially Oregon, define their classes of driver's licenses in terms of commercial activity. If there is no evidence that your private automobile (car or truck) is engaged in any commercial activity for hire and or, that you are being paid to transport goods or

people as an employee, then there exists no jurisdiction for the Officer, Deputy, Prosecutor, or Traffic Court Judge to take any actions against you. Remember, a license is a government-issued permit to do something that is otherwise illegal.”

**These are Due Process charges in a Right to Travel case and cause** where one of the people repeatedly gets arrested and jailed for no lawful nor legal infraction; where, in Common Law, there is neither harm nor damage to anyone nor to any property and therefore is innocent of any trespass, though she has been unnecessarily harmed, charged, defrauded and trespassed -- even jailed and extorted -- repeatedly.

Due to the numerous infringements on her Constitutional rights and to multiple kidnaps, trespasses and imposed fines, the defendant will be opening a Civil court case into the Portland Federal District Court. We will provide the proceedings and facts from this Grand Jury into that case as evidence.

Here is the accounting of the events that occurred over the course of four (4) years: from February 2021, through this last Saturday, February 11, 2024, to one of our capable, honorable, responsible people, Michelle Ropp Hendricksen, a woman on the land and soil, Oregon:

On 9 February 2021, Michelle Rene Ropp Hendricksen©™, was stopped as a result of entrapment by city police Officer Brian Hagen in the Newberg, Oregon Fred Meyer parking lot. His reason for the stop was because of no front plate on Michelle's car. Michelle was arrested and taken to jail for, "failing to present and carry a driver's license". Officer Jeff Moreland was called in to assist.

On 9 March 2021, Michelle was again stopped by Officers Brian Hagen and Jeff Moreland in the Allison Spa parking lot, Newberg, for having "illegal" private plates. Tickets were issued by Officer Moreland for, "failure to present and carry a driver's license" and "failure to display license plates", but no action was taken to arrest.

On 28 March 2022, Michelle was approached outside of her car by Officer Brian Hagen in the Newberg Fred Meyer parking lot. He issued a \$10,000 ticket for displaying private plates.

On 11 August 2023, Michelle was stopped on I-5 in Clackamas County by an OSP Trooper. His reason for the stop, he did not recognize the private plates displayed on Michelle's car. Michelle was arrested and taken to Clackamas County jail for a bogus “Failure to Appear” (FTA) bench war-rant coming from Newberg MUNICIPAL Court.

On 10 February 2024, Michelle had breakfast with her mother, Bobby Graves and Trish House at J's in Newberg. As they were leaving, Officer Jeff Moreland came in with his teenaged daughter and son. Michelle recognized him and he her, but they did not exchange pleasantries. He also had a clear view of Michelle's car with her private plates from his table in the restaurant. After exiting the restaurant, Michelle and her mom traveled north on Hwy 99 west. Just after crossing the

county line into Washington County, Michelle noticed an unmarked black SUV tucked away on the left side. Michelle and her mom were in the right or the "slow lane". After passing the SUV, he immediately got onto 99 west and proceeded to stop Michelle and her mom in the Timberline Baptist Church parking lot. The reason for his stop, was because of no "state" issued plates were visible on Michelle's car. Michelle was again arrested for a bogus FTA bench war-rant coming from Newberg MUNICIPAL Court. Michelle was taken to Yamhill County jail (the long way to McMinnville) and proceeded to be violated with a strip search and extorted for \$1000 upon release a four hours later. It is Michelle's belief that Officer Jeff Moreland made a call and set her up to be harassed again by Sherwood PD, Officer Pierce. A subpoena for Moreland and Pierce's phone records would provide evidence, if this is in fact, true. Michelle is planning to open a Civil court case in the Portland Federal District Court.

Our Assembly has compiled a Travel Kit and in it is this form (shown on screen) entitled "Living Testimony in the form of an Affidavit of truth: My Right to Travel on Oregon". The form was autographed by Michelle and four witnesses.

We will now invite our Secretary, Tonja, to take roll and verify the bona fides of those present and in our jury pool as living flesh-blood-body-mind-soul-spirit men and women on the land and soil, Oregon.

We will now take the vote on behalf of Michelle Rene Ropp Hendricksen.

After which, depending on the Jury's decision, we will write a Presentment and a Notice of Arraignment to the offending entities with the charges of:

**Deprivation of Rights Under Color of Law" and "Deprivation of Due Process of Law".**

All 35 jurors present were a unanimous "yea" to the above charges. That was a unanimous vote from all jurors present (plus one out of state "yea" vote as a witness).

In the Presentment and the Notice of Arraignment all offenses and offending entities are listed, have been mailed to and given 10 working days (that is until the 29th of February, A.D. 2024, before we appear for them to defend and provide their bona fides.

The Presentment and Notice of Arraignment was printed on our stationery, autographed by our Clerk of Court and witnessed by 4 men & women in our Court of Record on Thursday, 15 of February 2024, and sent via registered mail (proof of service) to nine (9) of the parties and their colleagues (Notice to Agent is notice to Principal; Notice to Principal is notice to Agent) on Friday, 16th of February, A.D.2024.
